

## **OAI Jumpseat Agreement FAQs**

1. Who is Omni Air International?

OAI is a successful U.S. Part 121 charter air carrier. Our travel partners include major tour operators, cruise lines, sports/incentive charters, commercial airlines, and the U.S. Department of Defense. Our fleet consists of long-range DC10-30, B757, B767, and B777 aircraft.

- 2. How do I sign up for a seat on a flight?
  - Call the OAI Las Vegas Inflight Base Office at 702-795-3775 for flight schedule information during business hours, 0800 1600 M-F, Pacific time. Check in at the ticket counter/or gate and introduce yourself as a jumpseat rider. Please show your CREW ID.
- **3.** Who is eligible to travel under the Reciprocal Cabin Seat Agreement? Only active Flight Attendants are qualified to travel under this agreement.
- 4. Can an Other Airline Flight Attendant sit on cabin jumpseat?
  Yes, in fact, OAI currently flies from LAS-HNL-LAS for Vacations Hawaii as a charter.
  Vacations Hawaii requires that jumpseaters sit only in a jumpseat. Cabin seats may not be occupied by a jumpseat rider on these flights.
- 5. Can I utilize the Cabin Seat Travel Agreement while on leave? No, you must be an active, qualified flight attendant to travel.
- 6. What is my boarding priority when traveling on the Cabin Seat Travel Agreement?

Other airline flight attendants are boarded after OAI employees for Cabin Jumpseat in the order that they arrived.

- 7. Do I have to wear my badge when traveling under this Agreement?

  No. You would need to have your valid company ID with a "CREW" designator in order to travel but you would not necessarily display it on your outer wear once onboard the aircraft. However, when sitting on a cabin jumpseat, you are required to have your ID visible above the waist at all times.
- **8.** Is there a dress code when utilizing the Reciprocal Cabin Seat Agreement? Full uniform is required for Vacations Hawaii flights operated by OAI.
- 9. May I consume alcoholic beverages when utilizing the Cabin Seat Travel Agreement?
  No.
- 10. Are there blackout dates that apply to the Cabin Seat Travel Agreement?
- 11. Does this Cabin Seat Travel Agreement cover all flights system wide?

  Jumpseating is not allowed on OAI flights operated for the Department of Defense.

  As new commercial contracts are added, OAI will notify all parties.

**12. Are "lap" children eligible to travel under this Agreement?**No, infants, or "lap" children may not be accommodated under this Agreement.

## 13. Are cabin pets allowed to travel under this Agreement?

No, cabin pets cannot travel under this Agreement.
